1. The statement must be –
 - a. Signed by two members (over the age of 18) of the society who are appointed for the purpose in writing by the society or, if it has one, its governing body, and
 - b. Accompanied by a copy of the appointment under paragraph 1a (above).
2. This statement should be given to the local authority (Barnet Councils Licensing Team) no later than three months after the day on which the draw (or the last draw) in the lottery took place.
3. If after receiving a statement under paragraph 39 of Schedule 11 of the Gambling Act 2005 a local authority think that the Lottery to which the statement relates is a large lottery, they shall notify the Commission in writing.
