THE HIGHWAYS ACT 1980

AND THE ACQUISITION OF LAND ACT 1981

The London Borough of Barnet (in this order called "the acquiring authority") makes the following order:

1. Subject to the provisions of this order, the acquiring authority is under sections 239(3), 240(2)(a), 246(1), 250(1) and 260 of the Highways Act 1980 and the Acquisition of Land Act 1981 hereby authorised to purchase compulsorily the land and the new rights over land described in paragraph 2 for the purposes of:
 - (i) the improvement of certain highways in land, that include the removal of Perryfield Way gyratory and Herbert Road gyratory, widening of Station Road together with other associated, highways, junction and public realm improvements;
 - (ii) the use of the land in connection with such improvements;
 - (iii) the mitigation of any adverse effect which the existence or use of the improved highways would have on their surroundings;in connection with the development, redevelopment or improvement of the land at West Hendon.

2. (1)

The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in the London Borough of Barnet (West Hendon Major Highway Works) Compulsory Purchase Order (No. 2a) 2016".

- (2) The new rights to be purchased compulsorily under this order are described in the Schedule and the land is shown coloured blue on the said map
